Definition & Characterization of the Homeless Populations



Definitions

- U.S. Department of Housing and Urban Development (HUD) defines a person as:
 - Homeless: "lacks a fixed, regular, and adequate nighttime residence, and sleeps in a shelter designated for temporary living accommodations or place not designated for human habitation"
 - Chronically Homeless: "Either (1) an unaccompanied homeless individual with a disabling condition who has been continuously homeless for a year or more, OR (2) an unaccompanied individual with a disabling condition who has had at least four episodes of homelessness in the past three years."
 - Sheltered Homeless: staying in emergency shelter, safe haven, or transitional housing

National Statistics - Geographic Distribution



- Total in 2019: 567, 715
- Total in 2020: 580,466
- Highest Numbers (by state):
 - California: 161,548
 - New York: 91, 271
 - Florida: 27, 487
- For Comparison:
 - Massachusetts: 17,975

National Statistics - Demographics

Gender

- Men are more likely to experience homelessness account for 70% of individuals
- Females 30%, Transgender 0.8%, Non-binary 0.3%

Race

- National rate of homelessness 18 per 10,000
- Pacific Islander, Black or African American, Native American, Multiracial, and Hispanic populations have elevated rates of homelessness
- For total homelessness numerically, White Americans make up the largest group

National Statistics - Types of Homelessnes

Total Number of People Experiencing Homelessness per Year by Type, 2007–2020



<u>Subgroups</u>

- Individuals 70% of homeless population
- People in families with children 30%
- Chronically homeless 19%
- Unaccompanied youth (under age 25) - 6%

Homelessness in Massachusetts



Statistics of Worcester's Homeless Population

- Total 1,401 people homeless on a given night in Worcester city/county on any night in 2020
 - 16.9 per 10,000 people
- 7% increase in Worcester's homeless population between 2007 and 2020
- Median rent in Worcester \$1,450 (two bedroom apartment)

Health Risks

Health Risks

- Average life expectancy 50 years
- Less access to healthcare
- Higher rates of hospitalizations for physical health, mental health, and SUD

FIGURE 3. Unsheltered and sheltered adults who experienced trauma¹⁰

- History of ACE in homelessness
 - 85% of women
 - **77% of men**
 - (52% in general population)
- Trauma can be the cause or result of homelessness
 - Unsheltered women report trauma as a cause at higher rates than men

LIFT - Living in Freedom Together

- LIFT is a non-profit organization dedicated to ending the sex trade and to providing a community of support to survivors
- They offer:
 - Youth mentorship
 - Legislative advocacy
 - Court Advocacy
 - Recovery home
 - Vulnerability shelter
- Their mission: to end systems of prostitution through the implementation of the Equality Model.

The Equality Model addresses structures of violence, incorporates transformative justice, and breaks cycles of oppression.

- Jana's Place a recovery home for those who have experienced prostitution with substance use and mental health disorders
 - Provides mentoring, case management, in-house health care, life/job skills development
- HARBOR 15-bed low barrier-maximum vulnerability shelter



Eliot Community Human Services: PATH

- PATH: Project for Assistance in Transition from Homelessness
- PATH personnel provide services to individuals residing in emergency shelters, streets, or encampments throughout nearly 50 sites throughout the Commonwealth
- Outreach Clinicians and Engagement Specialists engage, assess, and collaboratively develop a recovery-oriented treatment plan that incorporates identified needs and preferences of the person served
- One of the many services provided by Eliot Community Human Services



Inspired to make a difference. Equipped to get it done.

Hector Reyes House





- Residential substance use treatment for Latino men
- Offers in house medical treatment and cognitive behavioral therapy
- Training and employment options designed to promote recovery and reduce odds of relapse
 - Café Reyes restaurant
- Anger management, financial literacy, and parenting groups



Individual Level



Providing Compassionate Care

- *Keep an open mind and get to know the patient's story.*
- *Remember that they are someone's family member, friend.*
- Common goal / language: Maintaining good health.



Systemic Level



Strategies

• "Housing first"

- $\circ \quad \mbox{Meet housing needs first} \to \mbox{then manage disease(s).}$
- Invest in new housing, subsidize low-income housing.
- MAT (medication-assisted treatment)
 - Methadone: Full opioid agonist given in controlled doses. Administered daily in methadone clinics.
 - **Suboxone**: Buprenorphine + Naloxone (Narcan). Prescribed med taken daily.
 - MAT shown to decrease overdose deaths.
- Supervised injection / consumption sites





State & Local Measures



State & Local Measures: Substance Use

- During 2020, opioid-related overdose deaths in MA rose by 5% to a total of 2,104.
- MA House Bill 2088 & Senate Bill 1272
 - 10-year pilot program
 establishing 2+ supervised
 consumption sites.
 - Virtual hearing held on 09/27/21.

Safe Consumption Sites Directly Meet the Needs of the BMC Community

Grayken Center for Addiction staff testified to the state on the need for safe consumption sites to address opioid overdose deaths.



State & Local Measures: COVID Relief

- MA: State government dedicated 20% of COVID relief budget towards funding new housing / low-income housing.
- Worcester: City government dedicated <20% of state aid to housing.
 - \circ Instead, Worcester increased police department funding \rightarrow funded efforts to police homeless population.

State & Local Measures: Tent Removals

- "Mass & Cass" in Boston.
 - Acting Mayor Kim Janey issued executive order on 10/19/21 aimed at clearing the 100+ tents set up in the streets since the summer.
 - Suffolk County Sheriff's Office now enforcing outstanding warrants.
- Worcester Blackstone River camp behind Walmart removed on 10/20/21.
- Healthcare providers / public health officials generally advocate for increased housing options, not tent removals.
