STANDING REPORTS

Chancellor's Updates

Dr. Collins congratulated Dr. Victor Ambrose on his receipt of the Nobel Prize in medicine, an exciting and wonderful accomplishment. We recognize how important his receipt of the Nobel Prize is for our medical school. In the first three days after the Nobel Prize award was announced, the medical school website received 1.6 billion hits.

Dr. Collins announced a \$5 million philanthropic gift from UMass Memorial Health and \$2.5 million in matching funds from the University of Massachusetts Foundation that will allow UMass Chan to establish five new 'UMass Memorial Health' endowed chairs. UMass Chan will formally celebrate these five distinguished clinical department leaders during a special Investiture Ceremony later this year. The inaugural holders of the five new UMass Memorial Health chairs are:

- A.M. Barrett, MD, chair and professor of neurology, for appointment to the UMass Memorial Chair in Neurology.
- Thomas J. FitzGerald, MD, chair and professor of radiation oncology, for appointment to the UMass Memorial Chair in Radiation Oncology.
- M. Diane McKee, MD, chair and professor of family medicine & community health since 2019, will be the inaugural holder of the UMass Memorial Ledwith Chair in Family and Community Medicine.
- Max P. Rosen, MD, MPH, chair and professor of radiology, has been named to the UMass Memorial Chair in Radiology.
- J. Matthias Walz, MD, chair and professor of anesthesia & perioperative medicine, has been named to the UMass Memorial Kaur Chair in Anesthesia and Perioperative Medicine.

Dr. Collins announced that the Board of Trustees also approved the establishment of the following endowed chairs and faculty appointments. The ceremony will be held in the Sherman Center Auditorium, November 20th at 4:00 pm.

- Anil Chandraker, MD, professor of medicine and chief of the Division of Renal Medicine in the Department of Medicine, is the inaugural holder of the Jack M. Wilson Chair in Biomedical Research.
- Stephenie C. Lemon, PhD, professor of population & quantitative health sciences and chief of the Division of Preventive and Behavioral Medicine, is the new holder of the Barbara Helen Smith Chair in Preventive and Behavioral Medicine.
- Fernando Martinez, MD, MS, professor of medicine, academic chief of the Division of Pulmonary, Allergy and Critical Care Medicine and inaugural vice chair for clinical and translational research in the Department of Medicine, is the inaugural holder of the Joseph D. Early Chair in Biomedical Research.

- Oliver Rando, MD, PhD, professor of biochemistry & molecular biotechnology, is the inaugural holder of the Endowed Chair in Biochemistry and Molecular Biotechnology I.
- Dorothy Schafer, PhD, associate professor of neurobiology, is the inaugural holder of the UMass Chan Medical School Chair in Biomedical Research I.
- Paul Thompson, PhD, professor of biochemistry & molecular biotechnology and director of the Program in Chemical Biology, is the inaugural holder of the Endowed Chair in Biochemistry and Molecular Biotechnology II.

Dr. Collins announced a new department chair appointment: Dr. Christopher Teng will be the incoming chair for the Department of Ophthalmology and Visual Sciences. He also expressed his appreciation for Dr. Johanna Seddon, who served as Interim Chair of the department since January 2023.

Dr. Collins congratulated Dr. Will Flavahan who received an NIH Director's New Innovator Award. This is a prestigious five-year 1.5-million-dollar grant initiative designed to support exceptionally creative early-stage investigators who propose highly innovative research projects with the potential to impact areas important to NIH's mission. Dr. Flavahan proposes to build upon a technique developed in his lab to generate comprehensive "training libraries" of DNA and RNA modifications that will expand the capabilities of third-generation sequencing for multi-dimensional genome and transcriptome analysis.

Dr. Collin's also congratulated the Vice Provost for Faculty Affairs, Professor Mary Ahn, along with the Vice Provost for Health Equity Professor Milagros Rozal for completing the 2024 Hedwig van Ameringen Executive Leadership in Academic Medicine fellowship at Drexel University College of Medicine this year.
